## Membership Categories Defined

<b>Providers</b>	Regulated child care facilities that provide direct early child care and education services to children. Providers are classified as Family, Group or Center.
<b>Child Care Information Services/ PA Regional Keys</b>	Two types of agencies that provide valuable child care information and services to providers and to various other publics and are part of the vital statewide continuum of community-based perspectives to the child care needs of families & communities.
<b>Community-Based Network</b>	Community-based networks for organizations & individuals interested in quality early education.
<b>Affiliate</b>	Affiliate members are individuals with an academic or personal interest in the mission of child care and who are not eligible in any of the above categories; examples include students, faculty and friends of child care.
<b>Associate</b>	Businesses, consultants, and other entities that provide a service or product to the child care provider community (e.g. children's furniture, educational material vendors, food suppliers, consultants, attorneys, accounting firms, insurance agencies, foundations, early childhood initiatives, colleges). They may be for-profit or not-for profit entities, private or publicly owned.
